As a concerned citizen, I am taking the opportunity to write my elected officials, other elected officials in Utah County and others who have a voice regarding the proposed land swap in American Fork Canyon. I write to implore you to speak up and prevent the land swap in American Fork Canyon before it is too late.

Let me be clear, I am a skier and I love the ski resorts like any other skier. However, I do not believe that swapping land in American Fork Canyon to Snowbird is the highest and best use of the land. Although ski resorts are generally good stewards of the land, they are in fact, for profit companies whose ultimate responsibility lies in creating profits for the shareholders of the company. Yes, Utah has world class ski resorts that bring many tourism dollars into the local economy. However, if Snowbird is allowed to expand into Utah County, the state and local governments will be forced to create infrastructure to support this expansion. I vote for no expansion into Utah County through a land swap in American Fork Canyon and I urge each of you to involve yourself in this discussion immediately to prevent an entity that doesn't include any representation for the citizens of Utah County from voting to swap Utah County lands to Snowbird for an expansion of the resort.

Not only do I object to the tax increases that would be levied to build supporting infrastructure, I object to the commercialization of American Fork Canyon. I beg each of you to hold American Fork Canyon as close to a natural state as possible to allow our citizens access to one of the last wild places nearby. I do believe that representatives from Utah County should work with the Forest Service to study and come up with a plan unique to American Fork Canyon for continued and future use and preservation of this amazing natural resource.

One last concern I have with a potential land swap to Snowbird is the impact on the watershed for the citizens of Utah County. With the predicted population explosion in the county, I think it would be reprehensible to allow expansion of ski resorts into American Fork Canyon. I worked in the ski resort industry for five years, and believe me, I love skiing. However, the water needs for snowmaking and impact on the watershed when associated restaurants, condos, and possibly even a ski town or resort base area are astronomical and once they are allocated to the ski resorts, there is no way to get them back. Just look at the major drought conditions being suffered in California and look at our own snowpack and low reservoirs. We can not support a ski town or ski resort expansion in American Fork Canyon. We need that water for the population growth that is expected over the next 20-30 years.

I beg of you, please, please, get involved and keep American Fork Canyon free from ski resorts. Let's put our minds together and create a unique plan for American Fork Canyon that will preserve our wild and beautiful place forever.
