From a strategy standpoint, I wonder if it's helpful to look at this as a sequence of questions or options that need to be answered. Some thoughts -

### LAND EXCHANGE

The LEX seriously confuses the process. To handle both in the same NEPA document would add much complexity and greatly expand the analysis. Plus, the purpose and need for the LEX would likely be different than for a permit expansion. Would seem best to inform the permittee that the agency will do one or the other but not both.

## MDP

- 1. Postpone consideration of the Mary Ellen proposal until a MDP amendment is submitted and accepted;
- 2. Inform Snowbird that some or all elements of their expansion proposal are accepted through screening, but that the FS will need a full MDP shortly after scoping is initiated to ensure that cumulative effects and connected actions can be addressed in NEPA; or
- 3. Inform Snowbird that some or all elements of their expansion proposal are accepted through screening. Tell them that the NEPA for the projects will proceed, but alert them that before any implementation can begin their MDP must be amended.

# **NEPA**

- 1. Accept proposal as is and initiate NEPA. (Option inform Snowbird tram is unlikely to be approved, but that the FS is willing to take it forward as the Proposed Action);
- 2. Inform Snowbird that the only proposal the FS is willing to take into NEPA is one with no tram & tell them to adjust their proposal accordingly; or
- 3. Deny/reject proposal expansion proposal in total because of Forest Plan Inconsistency and maybe other issues.

However, if it were me i would not send something like this to Snowbird. Instead, i think the next communication back to Snowbird would be to meet with them and have a "heart-to-heart" discussion about what the Forest is - and is not - willing to take into NEPA. Then a brief letter could follow that meeting, documenting agreements, next steps, etc.

This is sort of a classic case where the transition from front loading to special uses screening is sort of fuzzy....and it's maybe best to think about it as iterative.

Steve - I'm struggling a bit with a couple of things in the letter. One is the paragraph on P&N. You use quite a different model than I'm used to. I faxed you 4 pages from a NEPA manual i had. There is no absolute right or wrong with P&N statements...all the regulations say is that EIS must "briefly specify the underlying purpose and need to which the agency is responding in proposing the alternatives, including the proposed action." Also, in recommending a format for EISs, the CEQ regs recommend a chapter titled "Purpose of and Need For Action." It becomes important down the road though in determining what an adequate range of alternatives....i.e., reasonable alternatives are those that satisfy P&N...at least to some degree. Thus, if I understand the intent of the letter, the P&N statement might read something like -

There is a need cooperate with Snowbird's plans for ski area development of their private lands by authorizing additional use of areas of NFS lands in a way that maintains the roadless character of Major Evans Gulch and that does not greatly increase the potential for lift-served backcountry skiing entry into the White Pine drainage.

Without that sort of qualification, I don't know that you could exclude the original proposal from detailed study as an alternative in the EIS. If you assume it'll be an alternative anyway, I'm not sure it's worth the fight about whether it's the "agency's proposed action." While valid, that approach or interpretation isn't really defined in policy or regulations anyway. It's maybe important to think about a P&N statement that not only serves as a foundation for a Forest Plan amendment <u>and</u> a project proposal. Does the P&N statement you drafted which relies on private land open the question other areas of either Forest, e.g, Cardiff Fork, "Aspen Utah" off Daniel's Summit (

http://voice-of-deseret.blogspot.com/2007/12/little-sweden-subdivision-petitions-for.html ), Seven Peaks at Provo, etc.? Just a thought.

Guess the other concern is that it might be possible to agree to take some project proposal into NEPA now.....with the understanding that a real MDP must be prepared before substantial work on the NEPA

analysis can begin. I know how complicated this has been, but i fear that it will look like "the Forest Service took 6 months just to decide that an MDP is required, with still no light at the end of tunnel." I know too it's not really consistent with the approach we're trying to advocate in the training, but it's tough to get out the bind you're in with no actual MDP to work from. Allowing the MDP to be developed while NEPA scoping is in progress (for example) might help deal with some of the fallout.

Sorry to ramble...this is a tough issue!
